Terms of Office: See item 14 on agenda. 9. **Headteachers Report:** As read: IY highlighted various items new staffing NLT support appointment as well as maternity cover in Y5. Pupil numbers for September whilst slightly lower are still healthy. Attendance – last terms attendance better than the previous year. 94 pencils were given for 100% attendance last term. Q. Is staff absence tracked? A. Yes but confidential. Play Place is full and still very popular. Community - Charity work donations to our chosen charities' have been excellent. IY discussed recent correspondence from parents regarding snacks available from school and their nutritional value. IY asked governors for their steer on do we continue as we are providing healthy snacks or stop selling altogether. Governors agreed to continue as we are – ensuring smaller portion size and that what we sell is within current nutritional guidance New School website – will have a soft launch on 23 March 2016. Parents will be informed about this following the Easter break. 10. **Achievement Unlocked:** Governors presented with two papers around this new NYCC strategy held a launch event which IY,PE,AW,IB and AL attended. 12.	Finance: CR updated meeting regarding meeting with SB, IY, and Smart Solutions. SPG met 26/2/16. Projected carry forward was around £90k following various agreed spends c/f is now nearer£55k. Looked at 16/17 predicted still looks very to similar forecast. SPG agreed to spend an additional £20k leaving us with a predicted c/f £30k if agreed by tonight's meeting. All govs in favour to go ahead with works.				
13.	IY informed meeting about the potential school structures — Pete Dywer has written to all schools regarding the expectation that the education system is fully academised by 2020. PD message don't rush to become an academy but start looking at the way forward and how this may look for you. Groups of schools working together. IY gave a brief over view of where advisory services are going. Q. Has it been discussed with STAR? A. It is on Action Plan to discuss annually. Do governors want more information on the implications of Riverside becoming an academy? Governors agreed that exploratory work would be good and that we should be proactive in this. IY agreed to look at arranging an informative evening around risks and benefits.				
14.	Chairs term of Office/Governors term of office: IB left the meeting. Meeting considered letter written by IB regarding term of office for all governors. We don't carry out a 360 degree review of governors. What's right for the school? Needs to be a process of evaluation. Who does the appraisal? Suggestion made that Chair does governors and a Chair from another STAR school appraises the chair. Proposal IB stays as Chair until end of this academic year. Governors term of office — a governor can have multiple successive terms of offices and all governors will have an annual review linked to skills audit of governing body.
